- Owner agrees to pay all collection costs, including attorney fees and court costs, if account is referred for collection, to the extent permitted by Ohio law.

OHIO STABLEKEEPER'S / AGISTER'S LIEN

Ohio law may provide PowerPlay Farms with a lien for boarding, care, training, veterinary services, and other expenses. Owner agrees that PowerPlay Farms may exercise any rights available under applicable Ohio law, including but not limited to stablekeeper's or agister's lien procedures.

USTA FINANCIAL RESPONSIBILITY & LIEN PROCEDURES

If an unpaid debt is industry-related and PowerPlay Farms obtains a qualifying judgment or otherwise meets the requirements of the USTA Financial Responsibility Rule (20.09) or applicable USTA lien or judgment procedures, PowerPlay Farms may pursue available remedies through the USTA, including recording qualifying judgments or initiating lien-sale procedures, consistent with current USTA rules.



LIABILITY & RISK ACKNOWLEDGMENT

I acknowledge that horses are unpredictable and that equine activities involve inherent risks, including the risk of serious injury or death. I assume all risks associated with my horse(s) being on the premises and participating in any farm activities. I agree to release and hold harmless PowerPlay Racing 87 LLC (PowerPlay Farms), its owners, employees, agents, contractors, and affiliates from any and all liability for injury, loss, damage, or death to my horse(s) or to myself or others, except to the extent caused by the gross negligence or willful misconduct of PowerPlay Farms.

This agreement shall be governed by and construed in accordance with the laws of the State of Ohio.
